Micro-Enterprise Charter Academy Interim Assessment Report

California Department of Education (CDE) Analysis

As a new school, Micro-Enterprise Charter Academy (MECA) did not have a valid 2008 Base API, so it did not have any 2009 growth targets. MECA did not meet schoolwide Adequate Yearly Progress (AYP) criteria.

Representatives from MECA will be available at the May 2010 meeting of the State Board of Education to respond to questions about their Interim Assessment Report.

The CDE analysis is included beneath each required element of the Interim Assessment Report outlined below:

- 1. Assessments used by the school that demonstrate alignment to California academic standards for each grade level the school offers as well as alignment to all academic goals stated in the school's charter.
 - a. MECA submitted one sample mathematics assessment and two sample English-language arts (ELA) assessments. It is not clear which assessments were used at which grade level.
- 2. Benchmark data from October 2009, February 2010, and April 2010 for students schoolwide and in each subgroup.
 - a. MECA provided all of the requested data regarding the number of proficient students in mathematics and ELA, disaggregated by grade, strand, and demographic subgroups. MECA also provided data for individual students that indicate whether each student is proficient in each strand.
- 3. Evidence that the goals stated in the school's SAP are being achieved schoolwide and for each subgroup as demonstrated by the April 1, 2010 data.
 - a. The data submitted by MECA indicate decreases averaging two to three percent in the number of students that are proficient in mathematics for all three grade levels. ELA results show mixed results regarding the number of students proficient in grades six and seven, with results ranging from a decrease of eight percent schoolwide in language conventions to an increase of eight percent for all African-Americans in language conventions. Writing proficiency is largely higher, with an increase of sixteen percent in the number of students proficient schoolwide but a decrease of two percent for eighth grade writing results.
