
### Initial Response



## Special Education Guidance for COVID-19


Some of the areas addressed in CDE's guidance include:

- Must all Individualized Education Programs (IEPs) be amended to reflect the change to distance learning?
- Is a Local Educational Agency precluded from providing services to students with disabilities in-person or in the home for the purpose of supporting the student in accessing the alternative options for learning being offered?
- What is considered equitable access for students with disabilities?




### Moving Forward

- Continued collaboration with parents, schools, service providers, and other critical partners




#### Innovative Solutions Webinars

# Innovative Solutions Workgroup Background

- The CDE convened an ad hoc workgroup
  - The purpose of the workgroup was to assist educators and families across the state of California with distance learning as the new format for education during the coronavirus pandemic by developing solutions and resources that can be used to help support students with disabilities.



## Innovative Solutions Workgroup Members

- The workgroup consisted of stakeholders throughout California
  - Over 130 participants
  - Included parents, teachers, service providers, administrators, representatives from professional organizations and other stakeholders
- Meetings were facilitated through a collaboration of staff from the CDE Special Education Division and WestEd
- Dona Meinders (WestEd), Monica Pecarovich and Aaron Christensen (CDE) led the project



# Innovative Solutions Workgroup Meetings

- Meet one hour every Friday from late March through the end of April
- At the meetings, participants would break into subgroups: Administration, Behavior and Mental Health, Early Childhood, Mild/Moderate Support Needs, Extensive Support Needs, Low Incidence, Nonpublic Schools/Agencies, Parent and Family, Related Services, Transition



## Innovative Solutions Workgroup Subgroups

- Discuss the current issues they were encountering, the solutions they were seeing in the field, and review resources they had found, or that had been submitted by the field
- Each subgroup created a resource document to
  - Outline the areas of concern
  - Discuss or list considerations
  - Provide examples of practice or solutions
  - Provide resources
