Proposition 98

Proposition 98 Funding by year in billions:

Local Control Funding Formula \$24.9 Billion Increase over 8 Years (Dollars in Billions)

Proposition 98

- K-12 Proposition 98 Spending reduced by ~\$12 billion relative to the GB
- Reduction achieved by:
 - Removal of \$1.6 billion worth of GB augmentations; ongoing SPED formula increase of \$645 million preserved
 - LCFF Proration of 10% ~\$6.4 billion
 - LCFF deferral \$5.3 billion
 - Several Categorical program reductions \$462 million

Special Education Reforms in the Governor's Budget

- Last year's ongoing special education funding allocation of \$645 million was contingent upon the adoption by the Legislature of special education funding and accountability reforms as part of the 2020 Budget Act.
- Reforms in areas such accountability, inclusive practices, and disproportionality to improve the outcome for students with exceptional needs.

Special Education Reforms

- The Governor's Budget proposed a multi-year process to improve special education finance, services, and student outcomes:
 - Initial Phase:
 - A new special education base formula which includes an ongoing investment of \$645 million.
 - A Governance and Accountability Study.
 - Work groups for IEP templates, Alternative Pathways to a Diploma, and Out-of-Home Care.

Special Education Reforms Initial Phase continued:

- Initial Phase continued:
 - Dyslexia research, training, and statewide conference.
 - Other special education funding remains unchanged until a finalized formula is adopted.
 - Flexibility with ERMHS funding.

Special Education Reforms Future Phases

- Future Phases:
 - Finalizing the special education funding formula.
 - Incorporating changes in statute based on continued research from the studies and workgroups.

Special Education Reforms Future Phases Continued

- Future Phases (cont):
 - Reforms related to family and student engagement, whole-child and family services, service delivery, non-public school placements, and other related services and programs.
 - Incorporating recommendations from other statewide efforts such early learning and care reforms and interagency collaboration.

Special Education New Base Funding

- \$645.2 million ongoing Proposition 98 General Fund to SELPAs.
- Allocated based on a 3-year rolling average calculated at the local educational agency level.
- All SELPAs will be held harmless to their 19-20 rate.
- Categorical special education funding remains unchanged at this time.
