

# ELPAC Participation Rate in the ELPI

The English Learner Progress Indicator (ELPI) uses the Summative English Language Proficiency Assessments for California (ELPAC) and Summative Alternate ELPAC taken each spring to report on the progress English learner (EL) students are making towards English language proficiency at their districts, county offices of education (COEs), and schools. To ensure that districts, COEs, and schools are testing all current EL students, they must meet or exceed a participation rate of 95 percent on the Summative ELPAC and Summative Alternate ELPAC. Since the 2024 California School Dashboard (Dashboard), districts, COEs, and schools will also be held accountable for meeting or exceeding the 95 percent participation rate for Long-Term English learner (LTEL) students.

Districts, COEs, and schools that do not meet the 95 percent participation rate on the Summative ELPAC and Summative Alternate ELPAC and have the minimum number of EL or LTEL students enrolled during the testing window (February 1 to May 31) will receive a modified ELPI Status rate on the Dashboard. Districts/COEs must have at least 30 EL students or 15 LTEL students enrolled during the testing window. Schools must have at least 30 EL or LTEL students enrolled during the testing window.

## Who Is Counted as Participating in the Summative ELPAC?

For the Summative ELPAC, EL students who log on to at least one domain (that is Listening, Speaking, Reading, or Writing) in each composite are counted as participating.

## Who Is Counted as Participating in the Summative Alternate ELPAC?

For the Summative Alternate ELPAC, EL students must be administered, at a minimum, one Receptive item and one Expressive item from anywhere within the assessment. Please note that a “Mark as No Response” is also considered a valid response and, therefore, counts as a completed item.

## Calculating the ELPAC Participation Rate

The ELPAC participation rate is calculated for any districts, COEs, or schools that meet the minimum number of students enrolled in the current Dashboard year based on ETS enrollment. The ELPAC participation rate is calculated as follows:



### Example

Chai Elementary School had 46 EL students enrolled during the Summative ELPAC testing window. Chai Elementary School tested 39 out of the 46 EL students on the Summative ELPAC and Summative Alternate ELPAC. The school's ELPAC participation rate is 84.8 percent (39 divided by 46 equals 84.8 percent). As a result, Chai Elementary School did not meet the 95 percent participation rate target.

## Participation Rate Impact

For each district, COE, or school that does not meet the 95 percent target, the minimum number of LTEL/EL students needed to reach a participation rate of at least 95 percent is determined. The resulting number of students will be counted as not making progress in the ELPI Status rate calculation.

### Example

Continuing the previous example, Chai Elementary School had an ELPAC participation rate of 84.8 percent.

This calculation shows the school needed to test 44 students to meet the 95 percent ELPAC participation rate:

**0.95 multiplied by 46 equals 43.7**

The **43.7** is rounded up to **44**, the number of EL students needed to meet the 95 percent ELPAC participation rate. The difference between the number of students needed to meet the goal and the number of students tested is determined:

**44 minus 39 equals 5**

These 5 students will be added to the denominator and counted as not making progress towards English language proficiency in the ELPI Status rate calculation.

| ELPI Methodology          | ELPI Numerator | ELPI Denominator | ELPI Status Rate | ELPI Status Level |
|---------------------------|----------------|------------------|------------------|-------------------|
| ELPI Status Rate          | 24             | 39               | 61.5%            | High              |
| Modified ELPI Status Rate | 24             | 44 (39 plus 5)   | <b>54.5%</b>     | <b>Medium</b>     |

As shown above, Chai Elementary School’s ELPI Status level was High but with the modified ELPI Status rate, the school’s ELPI Status level is now Medium. This ELPI Status of Medium will be used, along with the Change, to determine the overall performance color for this school.
