Revision: Pending Legislation

Revision Addressed

- Senate Bill (SB) 1200 Academic Content Standards:
 - ELD Standards aligned to CCSS for ELA and also reflect key areas that align with the college and career readiness anchor standards
- Assembly Bill (AB) 1246 Instructional Materials:
 - No direct impact, however bill requires that local educational agencies purchase materials aligned with state standards.

Revision: Pending Legislation

Revision Addressed

- **AB 1719 Supplemental Instructional Materials: ELD:**
 - ELD Standards will inform the criteria for the ELD supplemental instructional materials
 - EL Support Division will collaborate with Curriculum Frameworks & Instructional Resources Division in the criteria development and adoption processes
 - Language from this bill was added to the Overview of the ELD Standards
- **AB 2193 Long Term ELs:**
 - Long term English learner definitional language was added to the Overview of the ELD Standards

Revision: Minor Edits and Changes

Revision Addressed

- Proficiency Level Descriptors and Grade K-12 Standards:
 - Minor spelling, grammar, and alignment edits were made to ensure consistency within and across K-12 standards.

ELD Standards Implementation

- Creation and Implementation of ELD professional learning modules to be developed in collaboration with Professional Learning Support Division, County Offices of Education and CA Comprehensive Center
- Bridging documents to articulate connections and gaps between former ELD standards and 2012 ELD standards.
- Transition guidelines document and related technical assistance.
- Creation of an Interactive and relational Web portal
- Continued collaboration with other CDE divisions to ensure integration of ELD Standards into other CDE implementation activities
