
# Executive Orders

  - Waive Physical Fitness Test


# Federal Waiver

# Development of Formative Assessment Resources for Science Instruction

- Instructional resources aligned with the CA NGSS will be developed through two virtual workshops with California science educators
  - April 27–May 20, 2020
  - May–June 2020
- Approximately 40 resources to be developed and shared with California educators statewide

# Update on the CAST Alignment Study

- CAST Alignment Study Completed
  - Posted on June 2020 on CDE's CAASPP Technical Reports and Studies Web Page
- Study results indicate the CAST forms consistent with SBE-approved November 2017 blueprint and items aligned with the CA NGSS.
- CAST alignment study submitted as part of Federal Peer Review June 2021
