Dear Members of the Advisory Commission on Charter Schools and Ms. Farland:

Alta Public Schools ("Alta") humbly submits this response to the Charter School Petition Review Form ("Staff Report") prepared by the California Department of Education ("CDE") regarding the charter renewal appeal for Prepa Tec Los Angeles High ("PTLAH"). We want to first thank CDE staff for partnering with us over the past five years to provide a high-quality education in Southeast Los Angeles, and for their extensive work in reviewing our renewal charter. We are grateful that there are only four minor issues raised in the Staff Report, all of which have already been fully addressed below. We humbly request that the Advisory Commission on Charter Schools ("ACCS") recommend approval of the PTLAH renewal charter. It would not be in the best interests of our community, and in fact would be extremely detrimental for our students, if PTLAH is forced to close. It has been an extremely challenging time, and our students need their school to come back to in the Fall. Even though the Los Angeles Unified School District ("LAUSD") Board of Education denied our charter renewal, the Board's Report and written findings adopted on December 8, 2020 agreed that such denial was not in the best interests of kids:

"[T]he District has determined that non-renewal and closure of the Charter School is *not* in the best interest of its students..."

(LAUSD Report, p. 22 [emphasis added].)

The LAUSD Board denial did not meet the legal standard. Under the legal standard, the renewal of a middle-performing school like PTLAH cannot be denied unless school closure would be in the best interests of students.

PTLAH is one of only four authorized public schools in Los Angeles that offers the IB Diploma Programme. Our students are among the most historically underserved in the State: 98.5% of students at PTLAH are Latino/a, 91.5% are socioeconomically disadvantaged, and 24.7% are English Learners. PTLAH first opened its doors in Fall 2016 and our plan all along was to grow slowly and steadily over the first charter term. We only served 9<sup>th</sup> grade students in 2016-17 and slowly added one grade level each year, which is described in our charter approved by the State Board of Education ("SBE").

Our school is still relatively new, but our students are already experiencing academic success. <u>Our first graduating class was in 2020 and we are extremely proud to have achieved a higher four-year cohort graduation rate (89%) than LAUSD (80.1%) and the State (84.3). We are also proud that our students have shown steady growth in ELA and Math over the current charter term, as demonstrated by NWEA MAP scores or "verified data" for purposes of Education Code Section 47607.2(c).</u>

Two of the five years that PTLAH has been open were impacted by the COVID-19 pandemic. This is an unprecedented time in public education, and an unprecedented time to judge a charter school in its first term. Many, many schools around the State are struggling academically and financially. Yet despite the challenges that are impacting every school, PTLAH is positioned to emerge from the pandemic in a positive academic <u>and</u> financial standing.

From an academic perspective, we have graduated students at a high rate, our attendance rates have been high, our staff retention rates have been high, and our students are experiencing growth in Math and ELA.

From a financial lens, PTLAH <u>has ended the previous two years with net income and is</u> <u>projected to end this current year with a positive fund balance</u>, which is the leading metric used to determine financial viability. PTLAH is only in its fifth year of operation, yet we are on a positive trajectory in both areas, unlike many district schools including in LAUSD.

We urge the State not to close PTLAH, especially at this sensitive juncture in time. PTLAH has made great strides in our very first charter term, in the midst of a global pandemic. We have made slow and steady growth. We respectfully request renewal of our charter so that PTLAH can continue this momentum full-steam over a five-year renewal term.

Again, we appreciate CDE's extensive time spent reviewing our material and we are grateful that there are only four minor issues raised in the Staff Report. Below is a point-by-point response to the proposed findings in the Staff Report, explaining how each of these issues has been addressed:

**Proposed Finding #1:** The charter petition is not "consistent with sound educational practice." (Staff Report, pp. 3-14.)

#### Petitioner's Response

It is extremely important to recognize the reason that PTLAH has limited Dashboard Data, which was entirely due to two factors: (1) our plan for a slow grade-level rollout that was approved by the SBE; and (2) the COVID-19 pandemic. PTLAH first opened to 9<sup>th</sup> grade students in 2016-

17 and then added one grade level each school year until serving all high school grades for the first time in 2019-20. Because only 11<sup>th</sup> graders participate in CAASPP testing at the high school level, and because CAASPP testing and the Dashboard were suspended last year due to the pandemic, PTLAH simply has very limited Dashboard data available.

It would be unprecedented to close a charter school based on a single year of Dashboard data (and we believe it would be acutely unfair under the current pandemic circumstances), especially when there are other positive data points evidencing PTLAH's academic success:

- ✓ Based on NWEA MAP scores, students who were continuously enrolled at PTLAH from Fall 2019 to Fall 2020 have experienced *zero learning loss* during school closures caused by the pandemic. In fact, continuously enrolled students have experienced *growth* in NWEA MAP scores on average over that time, and many students even outperformed their expected growth under normal circumstances notwithstanding the school closures.
- ✓ PTLAH students have experienced steady *growth* in NWEA MAP scores in ELA and Math over the current charter term.
- ✓ 61.1% of students in PTLAH's first graduating class are attending college, which is *one of the highest rates* of public schools in our region and *higher* than LAUSD's most recently reported college-going rate from DataQuest of 50.7%.

We were glad to see CDE recognize in the Staff Report that we have experienced increases in academic achievement based on our NWEA MAP scores:

"The CDE concludes that the verified data, overall, shows growth for PTLAH pupils."

(Staff Report, p. 13.) CDE also recognizes in the Staff Report that "the majority of [our] educational program is sound." (Staff Report, p. 3.)

As support for the proposed finding about our educational program, the Staff Report incorrectly states that PTLAH is not using standards-aligned curriculum for our ELD program. Our charter affirms in multiple places that we do in fact use curriculum that is aligned to the ELD standards (see, e.g., charter, pp. 62, 149, 241) and this is also reflected in our English Learner Master Plan that was submitted with the appeal materials (see, e.g., EL Master Plan, p. 16). Just like school districts, charter schools serving the high school grades are not required by law to use any specific single ELD curriculum. (See Ed. Code, §§ 60400, 47610.) As explained in the ELD standards document published on the CDE's website:

"The CA ELD Standards are not a curriculum or a curriculum framework. The CA ELD Standards describe what ELs should be able to accomplish if they receive high-quality instruction with appropriate scaffolding and instructional materials. The standards do not name a teaching method or the instructional materials to use."

(California English Language Develop Standards, p. 11.) READ 180 is an intensive intervention program utilized during designated ELD instruction to assist our EL students achieve the criteria for reclassification. Through carefully scaffolded reading, writing, and speaking activities,

students using READ 180 learn the phonological, morphological, syntactical, and semantic structures of English, including academic English. It appears that CDE does not approve of READ 180 at the high school level, however the data shows that our EL program works. EL students at PTLAH have shown steady *growth* in meeting ELA and Math standards based on NWEA MAP scores in *each year* of the current charter term, as recognized in the Staff Report (see pp. 6-7, 9-10.) Additionally, in our first year's graduation class, our EL students graduated at an 81.5% rate.

As additional support for the finding about our educational program, the Staff Report states that our charter does not include reasonably comprehensive descriptions of our educational program and governance structure. This is surprising, given our renewal charter is longer and more comprehensive that our current charter that was approved by the SBE in 2016. Our 383-page charter is substantive, specific, and more than meets the legal standard. LAUSD's Charter Schools Division, one of the most rigorous in the State, also agreed our petition was adequately comprehensive and found that our charter meets this requirement. We respectfully disagree with CDE's conclusion as to the comprehensiveness of our charter, and we believe this finding is based on minor issues that, as explained below, are not issues at all.

# **Proposed Finding #2:** The petitioner is not able to successfully implement the intended program. (Staff Report, pp. 15-19.)

## Petitioner's Response

PTLAH has worked hard to improve its financial condition over its very first charter term, even during the COVID-19 pandemic, unprecedented school closures, and funding uncertainty and deferrals. PTLAH is a new school that has operated for fewer than five years. It is not uncommon for a new charter school to end the first couple of years with negative net assets because of start-up expenses such as purchasing a large volume of curriculum, supplies, and equipment. For PTLAH, this challenge was compounded by the challenges with our facility. As PTLAH has hit financial challenges like any other school, we have communicated with CDE all along the way. CDE issued letters of fiscal concern to us each year and we responded timely and appropriately. As reflected in the Staff Report, each year "[t]he CDE determined PTLAH's response to be sufficient at the time of submission".

The Staff Report reiterates the same financial reserve requirement that was raised each year in CDE's letters of concern. We understand CDE has reserve requirements for charter schools, even though the law does not, but we also want to stress that it is extremely challenging for a new school to maintain the same level of reserves as an established school. The fact is that PTLAH's finances are on a positive trajectory. As acknowledged in the Staff Report, <u>PTLAH will end this current fiscal year with a positive fund balance, which is the leading metric used to determine financial viability</u>. While the school is projecting to fall below the 4% reserve requirement this year, our ending fund balance will be positive and therefore reflects a financially solvent organization. The financial action plan provided to CDE on March 29, 2021 shows the school surpassing the required 4% reserve by June 30, 2022 and continuing to grow thereafter.

The Staff Report also criticizes PTLAH's use of short-term financing to cover cash shortages, but we believe the majority of schools in the State are pursuing short-term financing at this time. Nearly all public schools in the State were required to look for outside financing due to

the deferral of LCFF revenues in light of the pandemic, and the California School Finance Authority even created a pooled borrowing program to help schools cover cash shortages. We respectfully believe it would be unfair to deny renewal of the PTLAH charter for addressing its cash flow needs in a similar or same way as the vast majority of public schools in California.

**Proposed Finding #3:** The petition does not present a reasonably comprehensive description of the educational program. (Staff Report, pp. 26-31.)

#### Petitioner's Response

This finding is based entirely on the ELD curriculum issue explained above. Again, our EL students are experiencing growth in academic achievement, which is evidence that our ELD program is assisting EL students in meeting standards.

**Proposed Finding #4:** The petition does not present a reasonably comprehensive description of the school's governance structure. (Staff Report, pp. 34-35.)

#### Petitioner's Response

It appears there has been a misunderstanding regarding the affirmation of compliance with the transparency laws under SB 126 (2019). The PTLAH charter clearly states on page 282:

"Charter School shall comply with the Brown Act and the California Public Records Act.

The Charter School shall comply with Government Code Section 1090, et seq., as set forth in Education Code section 47604.1.

Charter School shall comply with the Political Reform Act of 1974. (Gov. Code § 81000 et seq.)"

This is part of LAUSD's Federal, State, and District Required Language and is included in every charter petition submitted to LAUSD, and is adequate pursuant to LAUSD's rigorous standards for governance of charter schools. We respectfully do not understand what is missing from PTLAH's charter, that is reflected in other state-approved charters.

As for the PTLAH conflict of interest code, our code was approved by the Los Angeles County Board of Supervisors (the relevant code reviewing body) on December 9, 2020, i.e. <u>after</u> we submitted our renewal to LAUSD. The LA County process takes time, which is why the final code was not included with the appeal materials. A copy of our County-approved code is enclosed.

We want to collaborate with CDE and to the extent CDE requires PTLAH to bolster any of the descriptions in our charter, we are amenable to making such technical amendments. For example, we are happy to add the language suggested by CDE to Element 10 (suspension and expulsion procedures) and to the section on administrative services. As for Element 14 (dispute resolution procedures), our understanding has been that when the SBE grants our renewal, the SBE will work with PTLAH to designate either the Los Angeles County Board of Education or LAUSD as the chartering authority. (Ed. Code, § 47605.9(b).) This is why our letter describing changes to the charter that was included with our appeal materials as Exhibit 4 did not include dispute

resolution procedures specific to the SBE—we were under the impression we must include language specific to the County and/or LAUSD as our potential chartering authority.

We very much appreciate each of your time and consideration of our charter renewal. PTLAH is home for 326 students and 34 staff members, and we look forward to discussing these and any other issues, questions, or concerns at the ACCS meeting on April 13, 2021.

#### Incorporation of FPPC Regulation 18730 (2 California Code of Regulations, Section 18730) by Reference

The Political Reform Act (Government Code Section 81000, *et seq.*) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 Cal. Code of Regs. 18730), which contains the terms of a standard conflict of interest code. After public notice and hearing, it may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated into the conflict of interest code of this agency. This regulation and the attached Appendices (or Exhibits) designating officials and employees and establishing economic disclosure categories shall constitute the conflict of interest code of this agency.

# Place of Filing of Statements of Economic Interests

All officials and employees required to submit a statement of economic interests shall file their statements with the agency head; or his or her designee. The agency shall make and retain a copy of all statements filed by its Members of the Board of Directors and the Chief Executive Officer and forward the originals of such statements to the Executive Office of the Board of Supervisors of Los Angeles County.

Alta Public Schools shall retain the originals of statements for all other Designated Positions named in the agency's conflict of interest code. All retained statements, original or copied, shall be available for public inspection and reproduction (Gov. Code Section 81008).

## CATEGORY 1

Persons in this category shall disclose all interest in real property which is located in whole or in part within two (2) miles of any facility utilized by Alta Public Schools, including any leasehold, beneficial or ownership interest or option to acquire such interest in real property.

Persons are not required to disclose a residence, such as a home or vacation cabin, used exclusively as a personal residence; however, a residence in which a person rents out a room or for which a person claims a business deduction may be reportable.

## CATEGORY 2

Persons in this category shall disclose all investments and business positions in, and sources of income (including gifts, loans and travel payments) that are from, business entities engaged in the performance of work or services, or sources that manufacture, sell, repair, rent or distribute school supplies, books, materials, school furnishings or equipment of the type utilized by Alta Public Schools.

## CATEGORY 3

Persons in this category shall disclose all investments and business positions in, and sources of income (including gifts, loans and travel payments) that are from, business entities engaged in the performance of work or services, or sources that manufacture, sell, repair, rent or distribute school supplies, books, materials, school furnishings or equipment of the type utilized by the designated position's department.

## CATEGORY 4

Persons in this category shall disclose all income (including gifts, loans and travel payments) from any Alta Public Schools employee or any known representative or association of such employee, or any business known by the reporting official to be owned or controlled by such employee.

(Gov. Code Section 81008.)







Executive Director Joe Boyd RE: CTA COMMENTS REGARDING Item #4: Petition for the Renewal of a Charter School Under the Oversight of the Local Educational Agency Designated by the State Board of Education Pursuant to California Education Code Section 47605.9(b): Consideration of Prepa Tec Los Angeles High, which was denied by the Los Angeles Unified School District.

Dear ACCS Commissioners:

The California Teachers Association supports the California Department of Education's recommendation to not renew Prepa Tec Los Angeles High. While CDE's position matches the local district's decision to not renew the petition, there is still concern that the CDE's approach to renewals of SBE authorized charters is undermining the authority granted by the state legislature to the local district during the renewal process.

Prepa Tec's charter petition is currently authorized by the SBE. In 2019, AB 1505 repealed Education Code section 47605.8 (which had enabled the SBE to directly grant charter petitions) and replaced it with Section 47605.9, which provides that SBE-authorized charter schools must first submit a petition for renewal to the local district, and then may go to the SBE on appeal.

On December 12, 2020, the board of LAUSD unanimously voted to deny Prepa Tec's renewal petition and the district staff laid out a number of findings that support denying the renewal. Additionally, LAUSD submitted a Notice of Violation to Prepa Tec on October 15, 2020. CTA believes that the legislature intended for the local district to take on the role of defacto authorizer when requiring SBE authorized charters to start their renewal process under AB 1505 with the local district.

CTA continues to be concerned with the CDE's approach to SBE authorized charter appeals under AB 1505.
