The Charter was faced with many challenges over the past two years with the onset of the COVID-19 Pandemic and new learning requirements. However, the Charter leadership and staff remained open and fluid with their mission to maintain continuity of education for their students. In addition to receiving substantial amounts of one-time funding appropriations from the Federal and State governments during a funding determination year, the Charter executed their plan to maximize their resources to address the student's social-emotional health, physical safety, and technology needs while meeting their spending criteria. Additionally, they are in process of a facilities project that will span three fiscal years, 2022/23, 2023/2024, and end in 2024/25. Besides the reserve of thirty percent set aside for the facilities project all other unassigned balances will be used to meet the student's needs as the Charter continues to grow and develop.
