
# SCHOOL DISTRICT ORGANIZATION HANDBOOK

## Quick Reference Guide 10.1. Create or Abolish Trustee Areas

A proposal to create or abolish trustee areas for a school district may be initiated by the county committee on school district organization (County Committee), school district governing board (Governing Board), or by a petition of the registered voters within the school district.

Proposals initiated by the County Committee or by the Governing Board follow the same method for effectuating change. A petition by the voters follows a slightly different method. These two methods are illustrated in Flowchart 10.1, below, and described on the subsequent page.

## ▶Flowchart 10.1. Create or Abolish Governing Board Trustee Areas

### Method 1.

Proposal to create or abolish trustee areas for a school district initiated by county committee, school district governing board, or by petition of the voters where petition was signed by fewer than 10 percent of registered voters.

- Step 1 County Committee receives request/initiates action to create or abolish trustee areas. (*Education Code* (*EC*) Section 5019)
- Step 2 County Committee calls and conducts at least one public hearing in the district on the matter. (*EC* 5019)
- Step 3 At the conclusion of the hearing, the County Committee approves or disapproves the proposal. Disapproval results in the failure of the proposal.
- Step 4 If the County Committee approves the proposal and its resolution approving the proposal includes a declaration that the change furthers the purposes of the California Voting Rights Act of 2001 (CVRA) (*Elections Code* Section 14025 et seq.), the change takes effect at the next district election. Otherwise, the approval of the proposal constitutes an order of election. (*EC* 5020)
- Step 5 Proposal is placed on the ballot not later than the next succeeding election for members of the Governing Board. (*EC* 5020[a])
- Step 6 If a majority of those voting approve the proposal, any affected board member serves out his or her term, and succeeding board members are elected according to the selected method. (*EC* 5021)

## Method 2.

Proposal to create or abolish trustee areas for a school district initiated by petition of voters where petition was signed by at least 10 percent of school district's registered voters.

- Step 1 Petition proposing to create or abolish trustee areas is filed containing at least 10 percent of the signatures of the school district's registered voters.

  (EC 5020[c]) 1
- Step 2 Proposal is placed on the ballot not later than the next succeeding election for members of the Governing Board. (*EC* 5020[a])
- Step 3 If a majority of those voting approve the proposal, any affected board member serves out his or her term, and succeeding board members are elected according to the selected method. (*EC* 5021)

<sup>&</sup>lt;sup>1</sup> Prior to the placing the proposal on the ballot, the County Committee may call and conduct one or more public hearings on the matter. (*EC* 5020[c])

#### Notes

- Whenever trustee areas are established in a school district, provision must be made for one of the alternative methods of electing governing board members. (EC 5030). See Quick-Reference Guide 10.5 for more information.
