#### **Alternate ELPAC Blueprint Approval**

- California State Board of Education (SBE) meeting, the SBE:
  - Approved the Alternate ELPAC test blueprint; and
  - Authorized CDE staff to make technical edits.

## Accessibility Resource Usage Study

## **Background (1)**

Accessibility resource categories for California's assessments:

- Universal Tools
- Designated Supports
- Accommodations

## **Background (2)**

- Designated supports and accommodations are made assigned only to eligible students.
- Test Delivery System captures whether designated supports or accommodations are used by a student.

## **Guiding Questions**

- Are accessibility resources assigned in targeted ways tailored to the unique needs of students?
- •What is the continuity of student use throughout the test?

#### Purpose

- To study the assignment and usage of designated supports and accommodations
- Descriptive in nature only
- Assess how/where students appear to be using designated supports

## What Was Being Evaluated?

- Patterns of accessibility resource use for individual students
- Relationship between assignment of accessibility resources and their operational use
- Any trends of relative use to test characteristics and performance

- Text-To-Speech
- •American Sign Language (ASL)
- Print on Demand
- Masking
- Audio Transcript
