Closed Session

The Board met in Closed Session from 8:00 a.m. to 9:35 a.m.

Call to Order: Public Session

President Hastings called the meeting to order at 9:47 a.m.

Salute to the Flag

Mr. Godfrey led the Board, staff, and audience in the Pledge of Allegiance.

Closed Session Report

Ms. Steentofte reported that in the morning's Closed Session the Board heard an update from their attorneys on *Williams v. State of California*. No action was taken. The State Board also heard an update on *California Association of Private Special Education Schools v. California Department of Education* and took action to not accept a settlement offer. The State Board heard an update on *Californians for Justice Education Fund v. State Board of Education* and took action to not accept the attorneys' fees offer. The State Board heard an update on *Emma C. v. Eastin* and gave direction to their attorneys regarding attorney fees. Finally, the State Board heard an update on *California State Board of Education v. Eastin* and took action to enter into a settlement agreement.

Announcements/Communications

President Hastings announced that Item W-10 would be heard after Item 32; and Item W-13 was withdrawn. Ms. Franklin informed the Board that Item W-12 was withdrawn; and Items 39 and 41 were postponed to the May meeting.

Caroline Roberts, School Health Connections and Healthy Start Office, provided an update on the regulations. The public hearing was held on March 9, 2004. Ms. Roberts explained the proposed technical corrections, which were not substantive and did not require a 15-day notice.

last-minute memorandum, the proposed regulations regarding Vision Testing and direct
staff to complete the rulemaking package and submit it to the Office of Administrative Law
for approval. Ms. Johnson seconded the motion. The motion was approved by unanimous

Wendy Harris, School Improvement Division, provided background information and explained the recommended options.

The Board held an in-depth discussion.

Ms. Harris, Pat McCabe, Policy and Evaluation Office, and Sue Stickel, Deputy Superintendent of the Curriculum and Instruction Branch, answered questions from the Board.

President Hastings requested the CDE staff to come back to the Board with a list of all the current schools in II/USP, raw API scores, growth over the past two to three years, the current API rank and the similar schools rank. He also requested a summarization of II/USP by cohort, funding, and performance.

President Hastings explained the complication of delaying this issue. He noted that a waiver request related to this waiver policy had now been brought before the Board twice. The waiver has already been deferred once but should it be deferred a second time, the waiver would automatically be granted according to law.

Mr. Nuñez stated that he would like to see information on how many schools qualify under the option.

Ms. Belisle noted that waiver policies before the Board are a housekeeping matter. They are not precedent setting but are direction to the CDE and SBE staff for arranging the consent calendar.

State Board Meeting Schedule

Ms. Reiss requested the Board's input about returning to meeting every month since the Governor is about action and there are many important educational issues being faced.

The Board held an in-depth discussion.

President Hastings noted that the previous every month meetings presented the Board with tactical issues. He explained that the current schedule is meant to allow the Board more preparation time in order to be more strategic and thoughtful about the major issues. Ms. Belisle commented that the current cycle promotes thought for the issues, analysis of comments for regulations, and provides Board members with more time for other areas of involvement (e.g., their work as liaisons). Superintendent O'Connell stated that the current cycle has improved quality of agenda items and enables the CDE to spend more time assisting the districts.

President Hastings noted that the annual review for the every-other-month schedule is slated for the May meeting, at which time the liaison assignments would also be addressed.

Judy Pinegar, Waiver Office, provided background information. Ms. Stickel addressed questions from the Board.

The Board held an in-depth discussion.

Ms. Belisle stated that there had been no specific requirement for districts to notify parents or students of the Algebra I graduation requirement. She recommended sending out an additional letter to ask school districts why they are not submitting waiver requests because their had been little response. Ms. Belisle noted that Assembly Member Darrell Steinberg and Senator Poochigian have taken a special interest in this issue. She acknowledged Ms. Stickel for being instrumental in helping to fashion a solution.

Superintendent O'Connell noted that Algebra is a basic skill in our global economy and it is a foundation for all the other math programs. He stated that students who are not exposed to algebra forego their ability to succeed in both college and the workplace. More than 75 percent of those occupations that require certification by exam demand that students know algebra. Superintendent O'Connell commented that when the California High School Exit Exam was postponed, some people mistakenly thought that since algebra is contained in the exam that the algebra requirement would also be delayed.

 - (2) The school is to revise all outcomes, including those related to academic achievement, to provide measurable benchmarks against which to assess outcomes.
 - (3) The school is to provide specific information about the frequency of the school performance evaluation, what the evaluation will include, and how the information will be reported to parents and other interested parties.
 - (4) The school is to provide annual training for governing board members on the requirements of the Brown Open Meeting Act.
 - (5) The school is to conduct annual surveys of faculty and staff regarding the school's educational program and operation, and provide the results to CDE oversight staff.
 - (6) The school is to provide information regarding its proposed plan and timeline for securing permanent staff or vendors for its business management services.
 - (7) The school is to report on its efforts to fully engage parents in all aspects of the school's operations.
 - (8) The school is to amend the charter petition in conformance with the CDE recommendations on pages 6 –15.

Ms. Johnson seconded the motion. The motion was approved by unanimous vote of the members present.

The center takes direction and guidance from both agencies. Caroline Roberts, School Health Connection and Healthy Start Office, explained that the Alameda County Office of Education agreed to house the resource center over ten years ago. It houses a number of nutrition, health and physical activity-related contracts.

Ms. Reiss requested an amendment to include a strong recommendation to have the center coordinate these activities with the Secretary of Health and Human Services and the Governor's Council on Physical Fitness and Sports. President Hastings requested that Ms. Bramson-Paul convey this recommendation to the Alameda County Superintendent of Education.

 ACTION: Ms. Reiss moved to approve expenditure of \$70,200 to support a contract with the California Healthy Kids Resource Center, as recommended by staff, with condition that the California Healthy Kids Resource Center coordinate efforts with the Secretary for Health and Human Services and the Governor's Counsel on Physical Fitness. Ms. Martineau seconded the motion. The motion was approved by unanimous vote of the members present.
