Closed Session

The State Board met in Closed Session from 8:08 a.m. to 8:42 a.m.

Call to Order: Public Session

President Hastings called the Public Session to order at 9:00 a.m.

Salute to the Flag

Mr. Godfrey led the Board, staff, and audience in the Pledge of Allegiance.

Announcements/Communications

President Hastings announced that Items 13, 15, and 22 would be on the agenda for the day; Item 48 would be presented at 10:00 a.m.; and Item W-5 was withdrawn.

Closed Session Report

Ms. Steentofte reported that the State Board heard updates on *Daniel v. State of California; Pazmiño v. California State Board of Education*; and *Williams v. State of California*. No actions were taken. The State Board also heard an update on *Ocean View School District v. State Board of Education* and took action to reject a proposed settlement agreement. Finally, the State Board heard an update on *Acevedo v. State of California*, and related cases, and took action not to appeal the decision.

Camille Maben, CDE Special Project Coordinator, provided an update. She noted that the Department had started working with the State Board staff on ways to improve California's state plan (i.e., amending the plan).

Bill Padia, Policy and Evaluation Division, reported on Phase II of the Annual Yearly Progress (AYP). The results would be released on Friday, November 14, 2003, on the CDE Web site. Mr. Padia summarized the participation rate appeals process. Out of 373 appeals, approximately 40 percent were approved, 45 percent were denied, and 15 percent were still pending data corrections through the contractor.

The following individuals addressed the Board: Stephen Rhoads, Strategic Education Services Sherrill Huffnagel, Superintendent, Delano Joint Union High School District Alan Martens, Associate Superintendent, Chaffey Union High School District

President Hastings commented that the problems with the participation rates on CAHSEE are the tight window of administration and limited make-up opportunities. Mr. Flores stated that for 2004, the examination would be reduced from three days to two days, one day for English-language arts and one day for mathematics. A census administration is scheduled for February and March. Schools that administer the test in February may use March as their makeup opportunity. An administration is also scheduled in May as a makeup opportunity for schools that are scheduled in March.

Anne Just, Title I Policy and Partnerships Office, reported on the program improvement appeals. Out of 193 appeals received, 52 were approved. The majority of appeals came in under the category of statistical error of participation rate. Another round of appeals will be coming in mid-November.

Mary Coronado Calvario, Curriculum Commission, reported on the denial of the Santillana publication submission. The Board held an in-depth discussion on the matter. Ms. Tacheny and Ms. Katzman thanked the Curriculum Commission and the Instructional Materials Advisory Panel (IMAP) and Language Experts (LE) for their work.

President Hastings explained that this is an issue of whether a publication meets the guidelines of adoption. Ms. Belisle stated for the record that the Board in the past has been the subject of litigation over these issues. There is a well-delineated process on how to get a textbook adopted in the state and there is no misunderstanding in any of our documents that an IMAP report cannot be relied upon. Ms.

Belisle stated that she does not want to give the publishing industry the misunderstanding that they have anything they can rely on at the IMAP level. The process ends with the adoption by the State Board.

Mr. Flores reported on the results for grades 5, 7 and 9. Only one-fourth of California students met all six of the standards. The indicators of aerobic capacity were met by about one-half of California students. The students are failing the body mass index or body composition portion of the test. These are leading to future health issues (i.e. Type II Diabetes and coronary disease issues). The Superintendent raised this as a challenge and encouraged schools to use the data available to them in order to define, refine, and improve their physical fitness programs.

Ms. Katzman suggested bringing back the Healthy Kids program that was developed a few years ago. President Hastings requested an agenda item in January 2004 on physical education.
