Draft ESSA State Plan Stakeholder Meetings

The California Department of Education is partnering with select county offices of education and other education organizations to convene stakeholder meetings. The purpose of these meetings is to review and gather feedback on the first complete draft of California's Every Student Succeeds Act (ESSA) State Plan. The State Plan describes how California will put into place federal programs that support:

- Low-income students
- Minority students
- English learners
- Migratory children and youth
- Neglected, delinquent, or at-risk children and youth
- Homeless children and youth
- Effective instruction
- Well-rounded education opportunities
- Community learning centers
- Rural and low-income schools

These meetings will take place during the public comment period, May 22–June 30. Any interested member of the public is welcome to attend. The State is eager to hear from educators of all levels and capacities, parents and families, and community-based and civil rights organizations.
